## **RESOLUTION APPOINTING ANIMAL CONTROL OFFICER**

At a regular meeting of the Town Board of the Town of Afton held on the 12<sup>th</sup> day of April, 2012, at 9:35 o'clock PM, at the town hall, and said meeting having been publicly noticed and publicly held at which a quorum was present in attendant and participatine thereat throughout, there were:

Present: Supervisor J Lawrence M Long C Tallmadge R Tallmadge

Absent: J Baciuska

M M Long moved the following resolution for adoption:

WHEREAS, there exsists a vacancy in the position of town animal control officer; and

**WHEREAS,** an application for such position has been submitted to the town and forwarded to the Chenango County Personnel Department for review and approval; amd

WHEREAS, the Chenango County Personnel Department has approved said application; and

**WHEREAS**, the town board is desirous of hiring said applicant upon the following terms and conditions.

### NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

The position of Town of Afton Animal Control Officer shall be a part time noncompetitive classified civil service position requiring the expenditure of less that 20 Hours per 7 day work week in the performance of official duties .

The town employee holding such position shall be eligible at such employee's sole option to enroll in the municipal employees' Tier 6 pension system.

The town employee holding such position shall not be eligible to enroll in the town employees' health care coverage system.

The rate of compensation to be paid to such employee shall be \$4635.00 annually.

The town employee holding such position shall utilize such employee's privately owned vehicle in the performance of official duties and shall be paid compensation for the use of said vehicle at the rate of \$.50 Per mile as invoiced monthly by said employee.

The official duties of such employee shall be as listed in the job description on file in the office of the Chenango County Personnel Department.

**AND BE IT FURTHER RESOLVED** that Amy Cross is hereby appointed as "Town of Afton Animal Control Officer": to assume such duties effective immediately, except prior to acting as such the town clerk shall cause Amy Cross to sign a written oath of office which said oath of office the town clerk shall file and maintain as a official town record;

**AND BE IT FURTHER RESOLVED** that the supervisor or town clerk shall cause to be filed with the Chenango County Personnel Deoartment a Form MAD-26 or other required form evidencing the employment of Amy Cross by the Town of Afton as is Animal Control Officer.
