New Business:



RESOLUTION 1,6-23

A RESOLUTION FOR THE TRANSFER
OF FUNDS FROM GENERAL ACCOUNT
UNASSIGNED FUND BALANCE TO
SUPPORT TOWN HALL ROOFING
REPAIRS

The Town Board offers the following and moves its adoption.

WHEREAS' The Town Hall was built in 2001 and it's roofing is now 22 years old, and

WHEREAS, many shingles have been replaced over the years and there is current damage to more shingles from wind damage, and

WHEREAS, the Town Board has the responsibility to maintain and protect the building from further damage, and

WHEREAS, the Town has applied for a State grant to assist in the replacement of said roofing shingles, but the time needed to process said grant is jeopardizing the building to further water damage.

NOW THERE FOR BE IT,

RESOLVED, that on approval of the majority of the Town Board that the roofing shingles will be replaced by the appropriate bidder that has submitted to an RFP by the Town, and be it further

RESOLVED, that the funds for such work in the amount of \$67,950. will be transferred from General Account Unassigned Balance to budget line A1620.41, Town Hall Repair.
