

**THE MINUTES OF THE REGULAR MEETING OF THE BOARD OF FIRE COMMISSIONERS OF THE  
AFTON FIRE DISTRICT  
June 11, 2015**

Letters of resignation were received from Commissioners Clint Austin, Bonnie Barr, Erin Noone and David Sabin. At 7:10 pm, present were Commissioner P. Vail, Treasurer Sandy Reiling and Chief Blane Reiling plus several visitors. After listening to our attorney David Garwood explain the process for establishing a new Board of Fire Commissioners, Commissioner Pete Vail appointed John Snel to fill the slot vacated by Erin Noone. He was sworn in by Dave Garwood. J. Snell moved, seconded by P, Vail that Tom Vail fill the spot vacated by Bonnie Barr. He was sworn in by Dave Garwood. Moved by T. Vail and seconded by P. Vail that J. Snel be Chairman. Approved unanimously. Moved by T. Vail and seconded by J. Snel that the board go into executive session to discuss possible candidates for the third slot. Approved unanimously. Moved by T. Vail, seconded by J. Snel that the board return to regular session. Approved unanimously. T. Vail moved that Theresa Sherman fill the slot vacated by C. Austin. Seconded by J. Snel. Approved unanimously. She was sworn in by Dave Garwood. After some discussion, it was decided to leave the remaining slot vacated by Clint Austin unfilled at this time.

-Treasurer Reiling reviewed the balances as of May 31, 2015. Checking (excluding this month's bills): \$2,496.55; Savings: 70,052.40; Equipment MM: \$13,518.27; Building MM: \$7,883.27; Equipment/Gear: \$8,502.37. P. Vail moved that the Treasurer's Report be adopted as presented. Seconded by T. Sherman and approved unanimously.
