Minutes of the meeting of the Board of Trustees held February 11, 2013, at 7:00 pm in the Susquehanna Room, 105 Main Street, Afton, NY

Meeting called to order at 7:00 PM

**Present:** Mayor Muller, Trustee Harvey, Trustee Zablocki and Trustee Matthews. Also present DPW Superintendent Richard Ramsey.

- A motion was made by Trustee Matthews authorizing Clerk/Treasurer to pay the following audited vouchers, seconded by Trustee Zablocki. All in favor, motion passed.

- Motion to accept previous minutes with no additions or corrections was made by Trustee Zablocki, seconded by Trustee Harvey. All in favor, motion passed.

- Code Enforcement: No representative. Mr. Metzger the code enforcer did speak with Trustee Matthews in regards the burned out property located at the end of South Main Street, next to Henry’s Dinner. This property is being handled by the County at this time. Mr. Metzger was still looking into the barn on Caswell Street at this time.
- Planning Board: No Meeting was held this month.
- Finance/Insurance: Up to date.
- Christmas Parade Committee: No Meeting was held this month. We are waiting to see if our application for a funding grant has been approved.
- Grant Committee: We are still looking for volunteers to form a grant committee.
